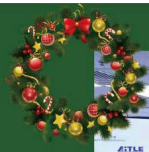

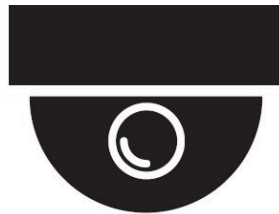

PCPD Issues New Guidance and Leaflets on the Use of CCTV System and Video Cameras on Drones and Vehicles

In view of the rapid development of low-altitude economy and smart surveillance technologies, the Office of the Privacy Commissioner for Personal Data (PCPD) today published a “Guidance on the Use of CCTV Surveillance” and a “Guidance on the Use of Video Cameras on Drones and Vehicles” to provide practical guidance on how to use CCTV systems, drones and in-vehicle cameras responsibly, so as to assist data users to make effective use of technology while ensuring the protection of personal data privacy in compliance with the relevant requirements under the Personal Data (Privacy) Ordinance (PDPO).
