

#### CA launched Drone system licence 通訊局推出無人機系統專用牌照

The Communications Authority today launched the new <u>Unmanned Aircraft System (UAS)</u> (<u>Private</u>) <u>Licence</u> to support the development of low-altitude economy.

The authority said that under the UAS (Private) Licence regime, licensees will be assigned the 1430-1444 MHz, or 1.4 GHz, band, as the dedicated spectrum for establishing, maintaining and operating radiocommunications installations for UAS operations.

It explained that the licence offers an additional communications solution to UAS operators beyond the current use of wireless local area networks and 4G or 5G mobile networks for data transmission and control, thereby enhancing support for the safe and efficient operation of UAS and supporting the development of a low-altitude economy ecosystem.

The UAS (Private) Licence is now open for applications from organisations participating in Low-altitude Economy Regulatory Sandbox pilot projects.

Interested parties can submit their applications to the authority. These should include information of the UAS they operate, approvals from the Civil Aviation Department on specific flight paths, and details of the radio base stations required.

The authority will rigorously review each application and closely monitor use of the dedicated UAS spectrum to ensure compliance with licence conditions and effective utilisation of spectrum resources.

通訊事務管理局推出<u>無人駕駛飛機系統(專用)牌照</u>,以支持低空經濟發展,現開放予低空經濟監管沙盒試點項目的參與機構申請。

通訊局表示,在無人機(專用)牌照制度下,牌照持有人可獲指配1430-1444兆赫頻帶即 1.4吉赫頻帶作為專用頻譜,以設置、維持和操作用於營運無人機系統的無線電通訊裝置, 為無人機活動提供除現時透過無線區域網絡及第四代或第五代流動通訊網絡進行數據傳輸和操作以外的額外通訊方案,進一步支援無人機安全高效運行,在通訊網絡方面全力支持低空經濟生態圈的建設。

牌照申請者可向通訊局提交申請及相關資料,包括所操作的無人機系統資料、民航處就特定 飛行路徑的批准、預計需要建設的無線電基站詳情等。

通訊局將根據申請人提交的資料嚴格審批申請,並密切監察無人機專用頻譜的使用是否符合 牌照條件,確保頻譜資源有效運用。

## Government promulgates Conceptual Outline of Development Plan for Innovation and Technology Industry in San Tin Technopole 政府公布《新田科技城創科產業發展規劃概念綱要》

The Government promulgated the Conceptual Outline of the Development Plan for the Innovation and Technology Industry in the San Tin Technopole. The Conceptual Outline provides a top-level design for the 210 hectares of new innovation and technology (I&T) land in the San Tin Technopole in terms of development vision, objectives and positioning, industrial spatial layout, and development model, thereby setting a clear development strategy for the San Tin Technopole.

In terms of a layout plan of the land, the new I&T land in the San Tin Technopole will be divided and developed into three development hubs and three industry development corridors (the three hubs and three corridors). They are the Hetao Hub, Chau Tau Hub, and Ki Lun Hub from north to south, and the life and health technology corridor, Al and robotics corridor, and microelectronics and advanced industry corridor. This planning structure can cater for the pace of I&T industry development and the relevant timetable for land resumption and site formation works undertaken by works departments. The development will have five phases, from introduction, industry ecosystem expansion, city-industry hub to consolidation.

政府公布《新田科技城創科產業發展規劃概念綱要》(《概念綱要》),從頂層設計新田科技城 210公頃新創科用地的發展願景、目標與定位、產業空間布局,以及發展模式,為新田科技 城訂下發展方略。

就用地布局而言,新田科技城的新創科用地會以三個樞紐、三個產業發展帶(三紐、三帶) 劃分和發展,即由北至南的河套樞紐、洲頭樞紐及麒麟樞紐,以及生命健康科技發展帶、人 工智能與機械人發展帶及微電子與先進產業發展帶。此規劃結構結合創科產業布局節奏和相 關收地和工務部門土地平整工程時間表,劃分為五個發展階段,從導入、產業生態延展、產 城中樞,以至完善階段。
