Rooted in Hong Kong for more than four decades, CAHK has been actively propelling the communications industry to raise its professional level by bringing together industry leaders. As AI technology rapidly develops, AI security has emerged as a vital facet of national security. The “Global AI Governance Initiative” (Initiative) promulgated by the Mainland in 2023 emphasised that the development and security of AI are of equal importance. The third plenary session of the 20th Central Committee of the Communist Party of China also adopted a resolution recently on the institution of oversight systems to ensure the safety of AI.

In support of the Mainland’s Initiative and to respond to industry needs, my Office published the “Artificial Intelligence: Model Personal Data Protection Framework” in June 2024 to provide internationally well-established and practicable recommendations as well as best practices to help organisations in the procurement, implementation and use of AI in compliance with the relevant requirements of the Personal Data (Privacy) Ordinance.

My Office looks forward to collaborating with CAHK and the industry to nurture the healthy and safe development of AI in Hong Kong, facilitate Hong Kong’s evolution into an innovation and technology hub, and propel the expansion of the digital economy in Hong Kong and throughout the Greater Bay Area.
