Background

The Communications Association of Hong Kong (CAHK), formerly known as Internet & Telecom Association of Hong Kong, is a non-profit making organisation incorporated on 27 May 1983 following the announcement of deregulation of the telecommunication products and services. CAHK is the association for Hong Kong's communications industry, with responsibilities across broadcasting, wireline and wireless communications, and other relevant business sectors in the domain of information and communications technology (ICT).

The Main Objectives Of The Association

- to organise formal and informal functions to provide networking and sharing opportunities for members of the Association to meet each other and explore business opportunities;
- to promote the awareness of and discussion on issues affecting all areas of the communications industry, and safeguard the interests and intellectual property rights of its members;
- to encourage the industry to develop and comply with the industry code of practice, technical and operational standards to maintain high standards of business and professional ethics and to discourage and suppress mal-practices that may be harmful to the communications industry as well as to businesses, community and the public at large;
- to provide legitimate and competent representations for various HKSAR Government Departments or other organisations for the communications industry;
- to educate, improve and elevate the technical and general knowledge of persons engaged in, or about to engage in the trade or the promotion of the communications industry or in any employment in connection with the industry;
- to produce useful information, research and statistics in connection with the communications industry, and to promote the industry image and members of the Association to local and overseas industry.

Services To Members

Business Luncheons

Organise regular business luncheons and invite high-profile guest speakers to address hot topics.

Membership Directory

Publish CAHK's own membership directory "Official Guide to ICT Industry in Hong Kong". The directory covers prominent business trends, latest market development, useful statistics and information as well as members' profiles.

Newsletters

CAHK's "New Services & Products Bulletin" provides an excellent channel for members to exchange new products and services information of their companies.

Information Services

Distribute consultation papers, latest telecom statistics, reports, market information and latest information of important issues from the government and main institutions.

Seminars & Exhibitions

Endorse or organise quality seminars or exhibitions for the benefits of members and increase the awareness of the Association in the industry or in the public.

聯會簡介

背景

香港通訊業聯會（前身為香港互聯網暨通訊業聯會）在一九八三年五月廿七日，在政府宣佈對通訊產品及服務放寬管制後成立。香港通訊業聯會是一家香港通訊行業商會，服務範圍涵蓋廣播、有線及無線通訊和其他與資訊科技領域相關之商業部分。

成立目的

- 策劃正式及非正式的活動，以供會員相互交流及分享，從而發掘更多商機。
- 促進與業界相關的討論，以保障會員的利益及知識產權。
- 鼓勵會員製定並遵守專業守則、營運標準，以維持高水準服務水平；並抑制有損通訊業，以至商界、社會及市民大眾的不良行為。
- 以通訊業合法及有力代表的身份，與政府及其他通訊行業相關的機構進行磋商。
- 教育及提升業界工作者的技術及一般知識。
- 製作與通訊業相關有用資料、研究及統計；推廣業界形象及為會員於本地及海外推廣業務提供協助。

服務範圍

午餐聚會

定期舉辦午餐例會，邀請知名人士出任講者，就業界關注的題目進行分析和討論。

會員名錄

定期出版《香港通訊業概覽》，探討及分析主流市場現狀及趨勢、提供參考資料，有用數據及會員名錄等。

內部刊物

收集會員最新產品或服務資料，定期出版內部刊物，增加交流。

資料服務

為會員提供最新通訊數據、研究報告、市場資料、重要通告及通訊事務管理局發出的諮詢文件等。

研討會/展覽會

支持或協辦高質素之研討會、展覽會，或協助會員舉辦新產品及服務展覽會。

組織訪問團

舉辦對外訪問團，讓會員早一步探索及了解開發新市場機會，以助釐定公司未來發展策略。

Delegations

Organise delegations for members to explore market for development and identify business opportunities outside Hong Kong region.

Presentations

Co-organise with institutions and government bodies on business forums and new product or service presentations.

Social Gatherings

Social networking with industry colleagues is the best way to meet with new business contacts and to exchange information on markets and trends. These networking functions are mostly open to members only and guests by invitation.

ATIE Forum

Organise delegations to participate in the Asian Telecom & Information Exchange (ATIE) Forum held in rotation in different Asian countries each year. By attending the Forum, members can exchange information and opinions, explore the course of mutual co-operation among participating associations to promote further development of the communications industry.

CAHK Homepage

The Association's homepage <http://www.cahk.hk> serves as an effective way of communication for members or visitors to get a quick view of the profiles of CAHK company members as well as an information channel for current activities and services.

Contact Point

Act as a focal point for overseas and local enquirers who seek to establish trade links in Hong Kong or undergo research.

Associate Company / Individual Membership

- engaged or having an interest in any aspect of the communications industry or in the promotion or development of the industry;
- nominated by two existing full members;
- Individual membership belongs to the applicant only and cannot be transferred.

Student Membership

Student members can be:

- Student members shall be persons over sixteen years of age at the time of membership application;
- engaged or having an interest in any aspect of the communications industry or in the promotion or development of the industry;
- post-secondary students and recent graduates from science, technology and engineering faculties in Hong Kong, or students from other faculties interested to serve in the ICT industry;
- Individual membership belongs to the applicant only and cannot be transferred;
