



In order to facilitate our Members to catch the gist of the Chief Executive's 2022 Policy Address delivered on 19 October, we have invited Ms. Lillian Cheong, JP, Under Secretary for Innovation, Technology and Industry, to elaborate on the key initiatives relating to us.

The "Chief Executive's 2022 Policy Address" Sharing Session was held on 1 November 2022. It was a collaborative effort quickly lined up by four industry associations. The Sharing Session has attracted 50 ICT industry executives to show up physically and more than 70 to have joined online. It was ended with great success because of the support and active participation from EXCO and CAHK Members.


